## **ITEM 0.2 TO CONFIRM THE MINUTES OF THE 46<sup>th</sup> MEETING OF THE GOVERNING BODY HELD ON 20.12.2021.**

Suggestions gave in 46<sup>th</sup> governing body meeting minutes:

## **ITEM 0.3 TO REVIEW THE ACTION TAKEN ON THE MINUTES OF THE 46<sup>th</sup> MEETING OF THE GOVERNING BODY HELD ON 20.12.2021.**

Based on the suggestions of 46<sup>th</sup> GB meeting, following actions have been taken:

1. Specialization wise faculty members were grouped. Department level specialization groups were formed. Faculty members were asked to have interaction with industry people to set up Centre of academic excellence in their departments. Work is already started. Now few centers are started like Robert Bosch GmbH.
2. We have a plan to start a new B.Tech. Programme in Big data and Data Analytics.
3. We encouraged our faculty members for publication in Scopus indexed journals. They published many papers in Scopus indexed journals. Our college is ranked in NIRF 2022 in the category of 251-300.
4. We formed a separate R&D cell. It has four faculties. They are the in-charges for verification of project proposals send to funding agencies like AICTE, DST, DRDO etc.
5. We advised all Ph.D completed lady faculties to apply for funding.
6. From this academic year, we have started a new UG programme – B.Tech. Artificial Intelligence and Data Science.

**ITEM NO.47.1 TO REVIEW THE AUTONOMOUS IMPLEMENTATION & RELATED INITIATIVES TAKEN BY THE COLLEGE**

- Our Institution follows Outcome Based Education system.
- Autonomous:
  - Autonomous status was received for our institute from UGC (No.F.22- 1/2017(AC), Dated 28.02.2017) and Anna University, Chennai (No. 1739/AU/CAC/2016, Dated 17.04.2017).
  - In connection with the Autonomous Implementation, BOS Meetings were conducted with Experts like Anna University representatives, Subject Experts, Industry Experts, Alumni, BOS Chairman and Senior Faculty Members. These meetings were conducted to finalize the curriculum and syllabi of various programmes as per the regulations R2019, R2020, R2021.
  - Standing Committee meetings were conducted to review the regulations, curriculum and syllabi of all under graduate and post graduate programmes, and to review the conduction of examinations. They were conducted with Chairperson, BOS Chairmen, and Member Secretary.
  - Academic Council meetings were convened with Chairperson, University Nominees, Experts nominated by the Governing Body, BOS Chairmen, Senior Faculty members and Member secretary. The recent meeting was conducted on 27<sup>th</sup> July 2022. The main agenda of this meeting is to approve curriculum & Syllabi for few UG and M.E. programmes and also to approve the changes in the conduction of internal marks exams, awarding letter grades based on marks, relative grading system as per the recent Anna University instructions.
  - Results of End Semester examinations under autonomous stream were discussed and approved by the result passing board meeting. The results are published.
  - We are going to apply for Autonomous status renewal in this year.

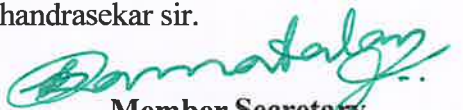
