And whereas, on the faith and strength of such representation and warranty, both EGSPEC and SAKTHI STEELS have agreed to enter into this Memorandum of Understanding as per the mutually agreed clauses as agreed below:

### 1. Definitions:

- 1.1 Wastepaper: Discarded paper including cardboard, newspaper and magazines, shredded papers, old office records, etc.
- 1.2 Plastics: Water bottles, polythene sheets, carry bags etc.
- 1.3 Steels: Unwanted steel tables and chairs, metals etc.
- 1.4 Designated Day: A Day in the week/fortnight /month agreed between parties.

#### 3. Quality and Quantity

- 3.1 Material should be free from food particles, without any contamination of garbage, municipal waste or any item which are detrimental.
- 3.2 Minimum required quantity is 300kgs.

# 4. Roles and Responsibilities of E.G.S.Pillay Engineering College

- 4.1 <u>E.G.S.Pillay Engineering College</u> shall identify the quantum of waste paper and plastic generated at various locations.
- 4.2 <u>E.G.S.Pillay Engineering College</u> would store the wastepaper and plastic and SAKTHI STEELS would pick up on mutually agreed schedule.
- 4.3 <u>E.G.S.Pillay Engineering College</u> agrees to appoint, Mr. Thamaraikannan, Admin, (Mobile No: 7373067072) as its representative to coordinate on various activities identified in MOU and to notify SAKTHI STEELS within one month of any change in responsibility.
- 4.4 <u>E.G.S.Pillay Engineering College</u> need to allocate for itself sufficient covered storage space for keeping the material safely.
- 4.5 A sale invoice in the name of SAKTHI STEELS shall be issued with GST to enable faster payment from SAKTHI STEELS. Invoice will be sent by post/ courier to the address given in this MOU within two days from the date of collection of material along with the copies of weighment slips.

## 5. Roles and Responsibilities of SAKTHI STEELS:

- 5.1 In consideration for enabling SAKTHI STEELS to pick up the materials from EGSPEC , SAKTHI STEELS pay to EGSPEC, the consideration amount based on weight record a (Rupees Fourteen) per kg for carton boxes, shedding paper, old news paper old magazines, old office records dustbin paper and Rs 10 (Rupees Ten) for dry waste plastic waste, metal waste etc.
- 5.2 SAKTHI STEELS will make necessary arrangements for collecting the waste paper, plastic & transporting to its godown.
- 5.3 SAKTHI STEELS shall not use or disseminate any confidential information printed on the wastepaper if the wastepaper is not properly shredded by EGSPEC and the information is legible.
- 5.4 From Operations Properitor Mr. M. SOMASUNDARAM, Mobile No: 9578729550 and from SAKTHI STEELS to coordinate on various activities identified in MOU and to notify EGSPEC, within one month of any change in responsibility.

#### 6. Term of MOU and Notice of Termination:

This MOU is open ended in nature; but shall remain valid for minimum Three years and can be terminated only for the second academic year with three months notice on either side given to other party in writing at their address mentioned at the top/any other address to be notified in future. Such notice shall be deemed to be properly given if sent by registered post or by courier to the other persons authorized to sign this MOU.
